## First Dog to Earn AKC Therapy Dog Excellent Title

She's a High-in-Trial obedience dog who has been called a "firecracker" in the obedience ring, but Ann Begun's "Jamie Lynn" completely changes her demeanor when she's doing therapy work.

It's Jamie Lynn's success as a therapy dog that resulted in her being the first recipient of the AKC Therapy Dog Excellent title (THDX). For this new title, started on July 1, 2014, dogs and their owners must have completed at least 200 therapy visits. THDX comes with a certificate and beautiful silver medal to formally recognize this level of achievement.

Registered through Furry Friends Pet Assisted Therapy (San Jose, CA), Jamie Lynn (who is now formally known as "Shimmy Shimmy Ko Ko Pup UD VER RE NAP NJP THDX") has spent about 4 years visiting seniors and children who read to her. The ages of the people this remarkable dog has visited range from 6 months to 105 years old.



Jamie Lynn has acted as an ambassador for the Hospice of the Valley's Pet Companion program at many events. On behalf of the AKC Therapy Dog program, congratulations and thank you, Ann and Jamie Lynn.

# Critter Doctor Column

A number of you spoke with me at the recent Captains Dinner about things you've noticed on your teams and whether they should be reported or not. In addition, it has been brought to my attention when current members attend the etiquette class with a new pet, that many of you are noticing your teammates obviously ignoring rules and guidelines that we've set up for the safety of our pets and the people we visit. And I've even received a few emails from members who are simply noticing nagging issues that they wish would get resolved, but don't want to point fingers! A couple people have noticed quite serious issues on their teams and were unsure as to how to proceed with reporting what they'd noticed and were concerned about. Given all of this, it seems to me that it is time to once again review how to report what you see, when to report what you see, and review what happens to those reports.

First, no matter what you have noticed, big or small, you should clearly identify the problem to your team captain. They are a volunteer just like you, but they have the added power of being able to approach the board of directors and myself for help solving larger issues. Small issues can be addressed by your team captains directly. For example, if you notice a teammate routinely showing up for visits without their Furry Friends t-shirt, badge, and/or leash, bring this to your team captain's attention. This does not require a formal report by your captain, but they do need to speak to that volunteer and remind them of why we wear our badges and t-shirts, and use our matching leashes; these items promote group uniformity and make us look like professionals.

If you notice a teammate's dog growling at another dog on your team, however, please let your teammate know immediately what you observed. From their end of the leash, they may not have seen the behavior occur. You also need to make the captain aware of your observation. By keeping your captain "in the loop," they can determine if this growling is most likely a onetime occurrence (e.g. one dog invaded another dog's space in a tight corridor and a growl occurred), or whether this growl is one of many and indicative of a larger issue of intolerance or incompatibility between dogs on your team. If growling is occurring routinely between members' dogs on a team, the board and I want to know about it! Your captain doesn't need to file a formal incident report IF no contact was made between the two dogs or a dog and a human. However, they do still need to report the growling so that I may step in and make my recommendations for how to proceed. Growling is a pre-aggressive behavior and needs to be addressed by me. I may decide to attend a visit so that I may observe the dogs myself; I may

suggest staggering these two dogs' visits (one does the first half hour of the visit and the other is "the closer"); I might want the dogs to come on opposite months for their visits; or finally, I might suggest moving one dog to a new team. For example, switching to a new team may be the easiest solution if one of the growling dogs is new to the team and thus a disruption not previously experienced.

If you have reported something to your team captain, regardless, of how big or small, they should address the issue. If you feel that a reasonable amount of time has passed and they still have not addressed the problem (or the person is still flagrantly ignoring the rules as outlined by your captain), then feel free to contact the Furry Friends board of directors. They are volunteers just like you and are happy to help you sort out what you are observing on your teams. They will help your team captain to clear up any issues that arise and will bring any behavioral concerns to my immediate attention.

I realize that it is such an old adage that there is no "I" in "team," but this really is true. We are all on the same team...Furry Friends Pet Assisted Therapy Services. We are all working together to lick loneliness in our communities. This is such a wonderful organization and we all benefit and thrive from continued communication and interchange of thoughts and ideas. Please continue to keep me abreast of what you are observing on your teams. I am happy to discuss any issue with you either via phone or email. Thank you to all of you who shared your experiences and frustrations with me over the years. I appreciate your faith in me and my ability to help you work through these issues and continue to have enjoyable, productive visits.

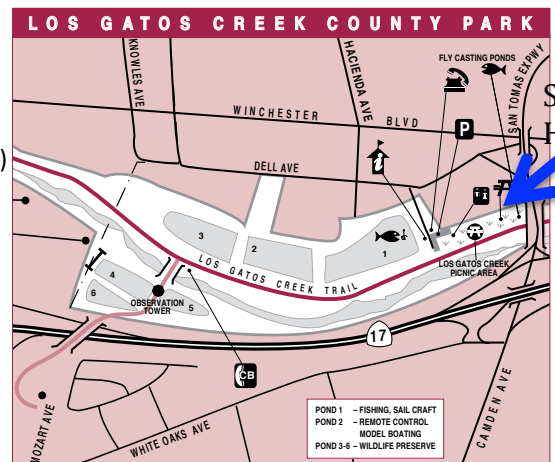
